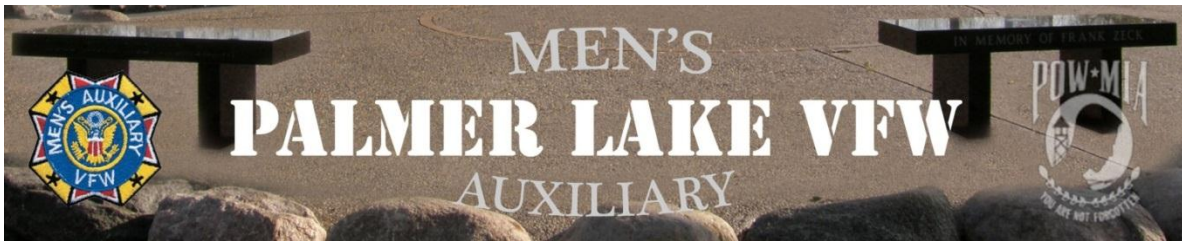
Please join us on Memorial Day for the service at Mound Cemetery at 11 am and after for lunch at the Post.

Our Spring Cabela's Raffle was on May 1. Results will follow next month.

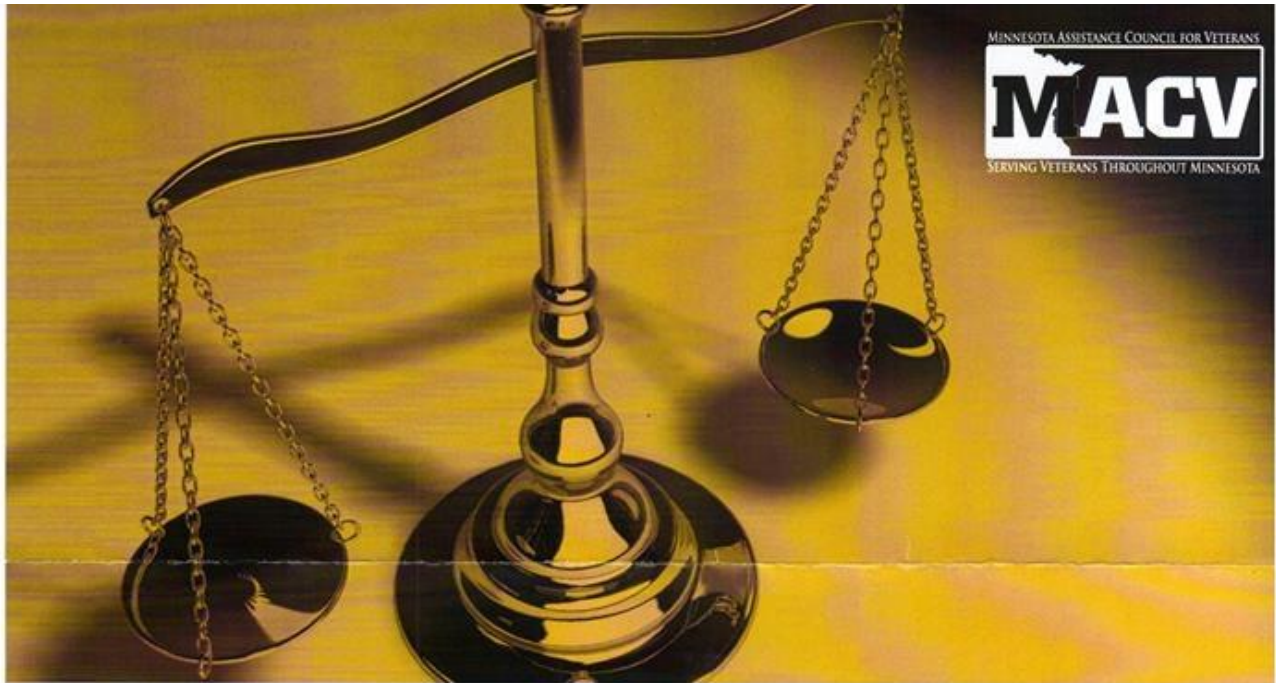
